The following work is proposed for converting this well to a water injection well:

Clean out to total depth, run Gamma Ray-Montren and caliper surveys. Cement 4 1/2" O.D. liner from bottom to at least 60' above 7" casing shoe. Perforate Premier Sand and acidise if necessary. Run 2-3/8" O.D. internally coated tubing with packer set above perforations.

Instructions
