Oil production has declined to 7 barrels of oil per day. We propose to frac treat the open hole with 15,000 gallons of gelled water with 15,000 pounds of sand down 3" tubing, using a packer in bottom part of casing. A gyp preventative chemical (L-135) will also be mixed with treatment. After pumping in 5,000 gallons, a rock salt plug will be pumped down to plug off first stage. After pumping another 5,000 gallon stage, rock salt will again be used as a plug before pumping in third stage of treatment.
