We propose to stimulate oil production by a fracture treatment of the open hole. We will run 3" tubing and set in 7" casing at approximately 3106'. We will use 3 stages, each stage consisting of 5,000 gallons Redi-frac plus 5,000# sand with 100# Gypban L-35. Rock salt plugs will be used between stages. On last test, the well pumped 6 barrels of oil plus 4 barrels of water per day.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
