Cleaned well out w/rotary tools and reverse circulation to T. D. at 3,278'. Deepened w/6" bit from 3,278' to 3,325'. Ran Gamma Ray-Neutron and Caliper logs. Ran 430' of 4 1/2" O.D. 10.5# J-55 snls csg for liner and set liner from 3,277' to 2,847', Halliburton cemented liner w/200 sx class C neat cement. WOC 96 hrs. Drill cement out of 7" csg to top of liner at 2,847'. Clean out liner w/3 7/8" bit, drilled shoe and drilled out below liner shoe w/3 7/8" bit to 3,287'. FBTD 3,287'.

AbrasiJet 2 holes per ft at 3,276', 3,275', 3,274', 3,273', 3,272', 3,271', 3,270', 3,258', 3,257', 3,256', 3,255', 3,254', 3,253', 3,252', 3,251'. Treated perforations 3,276' to 3,270' via 2" tbg below packer w/7,000# 20-40 sand and 10,500 gal slick water.

Treated perforations 3,258' to 3,251' via 2" tbg between bridge plug and packer w/7,500# 20-40 sand and 10,500 gal slick water.

Ran production tubing and rods and placed well on production 4-29-67.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
