Intend to clean well out to TD with reverse rig, run 2 1/2" tubing with packer set at 2880' and fracture treat well down tubing with approx. 45,000 gal gelled brine and 40,000# sand, 300# polyphosphates. Treatment will be through tubing in 6 stages separated by moth ball and rock salt blocks. Will then wash well out to TD, run tubing, rods, and pump, and return well to production.

Instructions
