DETAILS OF WORK

3-1/4" casing cemented at 624' with 50 sacks of cement.
7" casing cemented at 3047' with 100 sacks of cement and 50 sacks of mud.

Filled with mud from total depth of 3-33' to 3047' and set a cement plug at that depth, knocked off and pulled 7" casing. Filled with heavy mud to bottom of salt (315') and set a cement plug at that depth. Filled with heavy mud to 624' and set cement plug at that depth. Knocked off and pulled 3-1/4" casing, and filled with heavy mud to surface and set regulation 4" marker in cement.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
