We treated this well through perforations from 2766-2786 with 30,000# 20-40 sand plus 2000# 10-20 sand and 25,000 gals of slick water. 500 gals 15% DS-30 acid was pumped ahead of the frac.

Maximum pressure was 1900#. Minimum pressure was 1750#. Rate was 20-1 BPM. Overflushed with 15 barrels.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
