### WE PROPOSE TO DEEPEN THIS WELL AS FOLLOWS:

OBJECTIVE: Premier Sand.

NEW TOTAL DEFTH: Approximately 3090'.

ADDITIONAL CASING: Will run approximately 228' of 5-1/2" OD 15.5% liner from 2672' to 2900'. Liner will be humg at 2672' in 7" OD casing with a lead seal pack off liner hanger and cemented with 50 sacks of cement.

PROPOSED SHOUTING RECORD: In the event that commercial production is indicated from the Premier Sand this some will be shot with 100 qts. of solidified nitro glycerin.

DRILLING OPERATIONS TO RECOMMENCE: On or about April 28, 1951, with a Company owned National Machine.
