Anadarko hereby requests a Casing Integrity Test on this TA well. We will call the BLM Carlsbad Office (887-6544) 24 hours prior to test (so the test can be witnessed).

Reason for Test - our records show we neglected to keep the testing & records on this TA well updated.

Rational - the Metex & Premier zones of the Grayburg formation are potential "pay zones", but it is not economically feasible to re-complete this well at this time.

Downhole Info - CIBP @ 2712' (1986) w/ chemical water circulated. CIBP is above all perms. Well passed a Casing Integrity Test in 1986.

Securing the Wellhead - a tubing sub was placed in the wellhead, wellhead was packed off and appropriate valves & bull plugs were installed (in 1986).
