DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was spudded on Oct. 30th. 1951 and drilled to top of salt. On Nov. 2nd. 1951 ran 122' of 35/8" O.D. 28" lap weld casing and cemented with 50 sacks, using the Denton Oil Well Cementing Co. After the cement set 72 hrs. the cement plug was drilled and a 4 hr. test was taken by bailing note. Test showed a complete water shut off.
