This well was converted to water injection on May 29, 1965 and injection is currently down the 7" casing, set @ 2947'. Injection is into the Frontier Sand @ 3297-3305'. Tubing and a packer will be run in this well at a later date.

The Grayburg-Jackson Frontier Sand Flood was approved by your office by letter dated July 16, 1964. This report was an oversight on the part of the Operator since the new wells did not need a Notice of Intention to begin water injection.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
