This well was converted to a water injection well in April, 1964; injection started on 4-16-64 and continued until June 5, 1964. Total injection during this period was 16,608. Injection was again started on July 3, 1964, and then discontinued on 1-21-65, by which time a total of 41,080 bbls. had been injected.

There was no further injection into this well until 3-27-67 when injection was resumed by Ryder Scott Management Company.
