Convert to water injection well as follows:

1. Drill out cement retainer @ 2784' and clean out wellbore to TD.
2. Run 4 1/2" 11.6# J-55 casing and set @ 3500'. Cement casing back to surface.
3. Selectively perforate the interval 2750'- 3550'(OA).
4. RIH with Baker AD-1 packer on 2 3/8" tubing and set at ±2700'.
5. Inject through perforations 2750'- 3550'(OA).
