We will set approximately 600 feet of 8 5/8" 24# casing and cement with 50 sacks cement. We will set approximately 4,000 feet of 4 1/2" casing and cement with 200 sacks of cement. We will drill with rotary tools to a depth of approximately 4,000 feet to test the San Andres Formation, and complete the well through perforations.

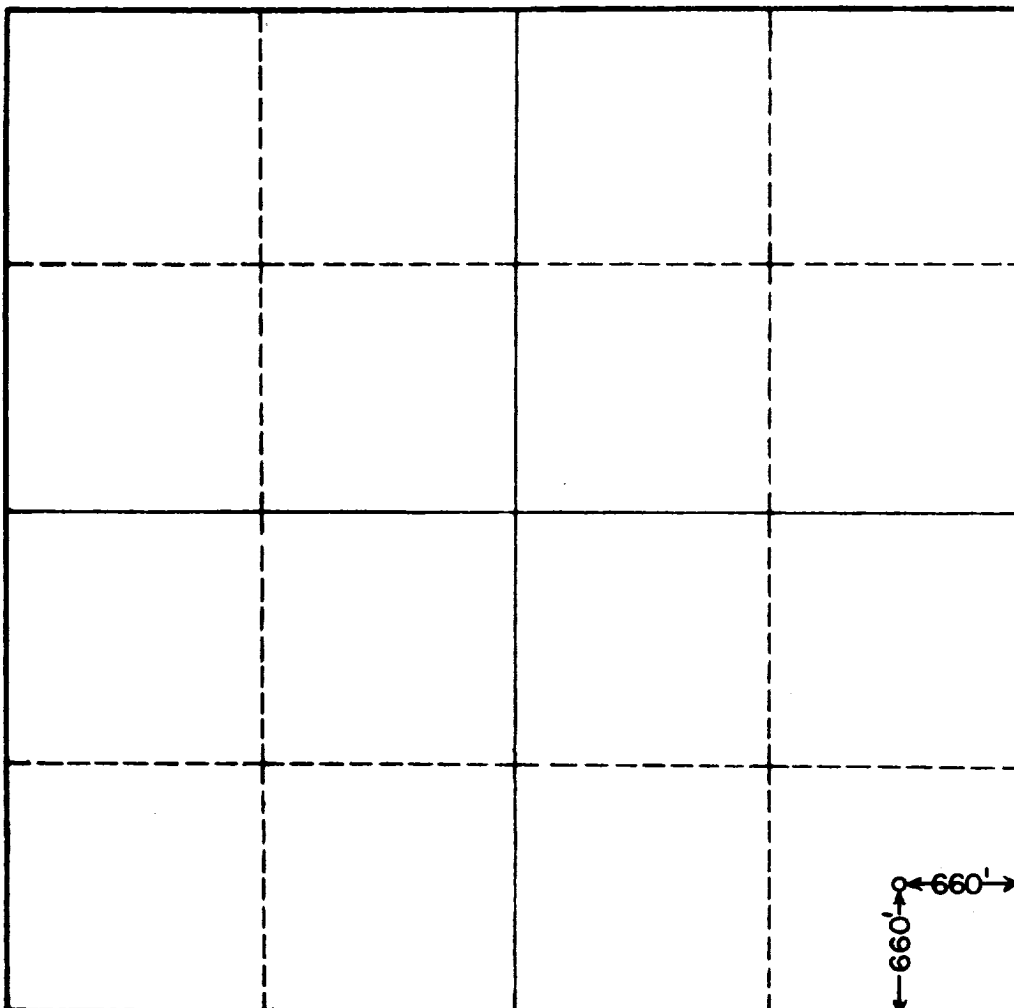
