Well is presently producing from open hole section 3247-3788' in the Grayburg and San Andres Formations. We propose to clean out, perforate and treat as follows:

1. Move in and rig up pulling unit.
2. Pull rods and tubing.
3. Run Gamma Ray Neutron Log.
4. Wash open hole section 3247-3788' with 500 gallons acid.
5. Selectively perforate 8-1/4" OD casing in the Grayburg Formation with six shots, if pay zone is present.
6. Isolate and treat new perforations in Grayburg with 1000 gallons acid.
7. Pull retrievable bridge plug.
8. Run tubing and rods and return well to a producing status.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
