- 1) Rigged up workover rig March 9, 1972. Pulled tubing and packer.
- 2) Ran 96 joints (3010.10') of 2-3/8" OD Duo-Line tubing with packer set at 3014'.
- 3) Treated down 7" OD casing annulus with 20 gallons Enjay #7674 Bactericide and 20 gallons Enjay #7720 corrosion inhibitor mixed with 100 bbls. fresh water. Circulated casing clean.
- 4) Hooked well to injection system and resumed injection of water into the Grayburg-San Andres formation through 7" OD casing perforations 3077-3237' and open-hole section 3365-3557'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
