Moved in and rigged up pulling unit. Pulled tubing and Baker Model "E" Seal Assembly, leaving Baker Model "F" 4-1/2"x2" Production Packer set at 3545' (open). Reran 2-3/8" tubing with Baker Model AD Tension Packer set at 2966'. (Previous approval had been granted to convert to dual injection, but did not have packer installed.) Water will be injected through 4-1/2" OD Liner into perforations 3201-3842' of the Grayburg and San Andres Formations. Well converted 3-28-68.

This will be a water injection well for the Skelly Unit, operated by Skelly Oil Company.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
