- (1) Moved in and rigged up workover rig 8/10/70. Pulled rods and tubing.
- (2) Ran 2-3/8" OD tubing, internally coated with Rice Engineering's Duxline plastic coating. Set Halliburton K-4, 5-1/2" x 2" packer at 3247'.
- (3) Loaded casing annulus behind tubing with water treated with inhibitors.
- (4) Hooked well to injection system and began injecting water on August 12, 1970, into open-hole section 3784' - 3910' and perforations 3300' - 3745' of the Grayburg-San Andres Pool.

This is a water injection well for the Skelly Unit, operated by Skelly Oil Company.
