The OCD will not approve the TA of the SWD. Please get the well reclassified to a producing well and petition the BLM for TA status.

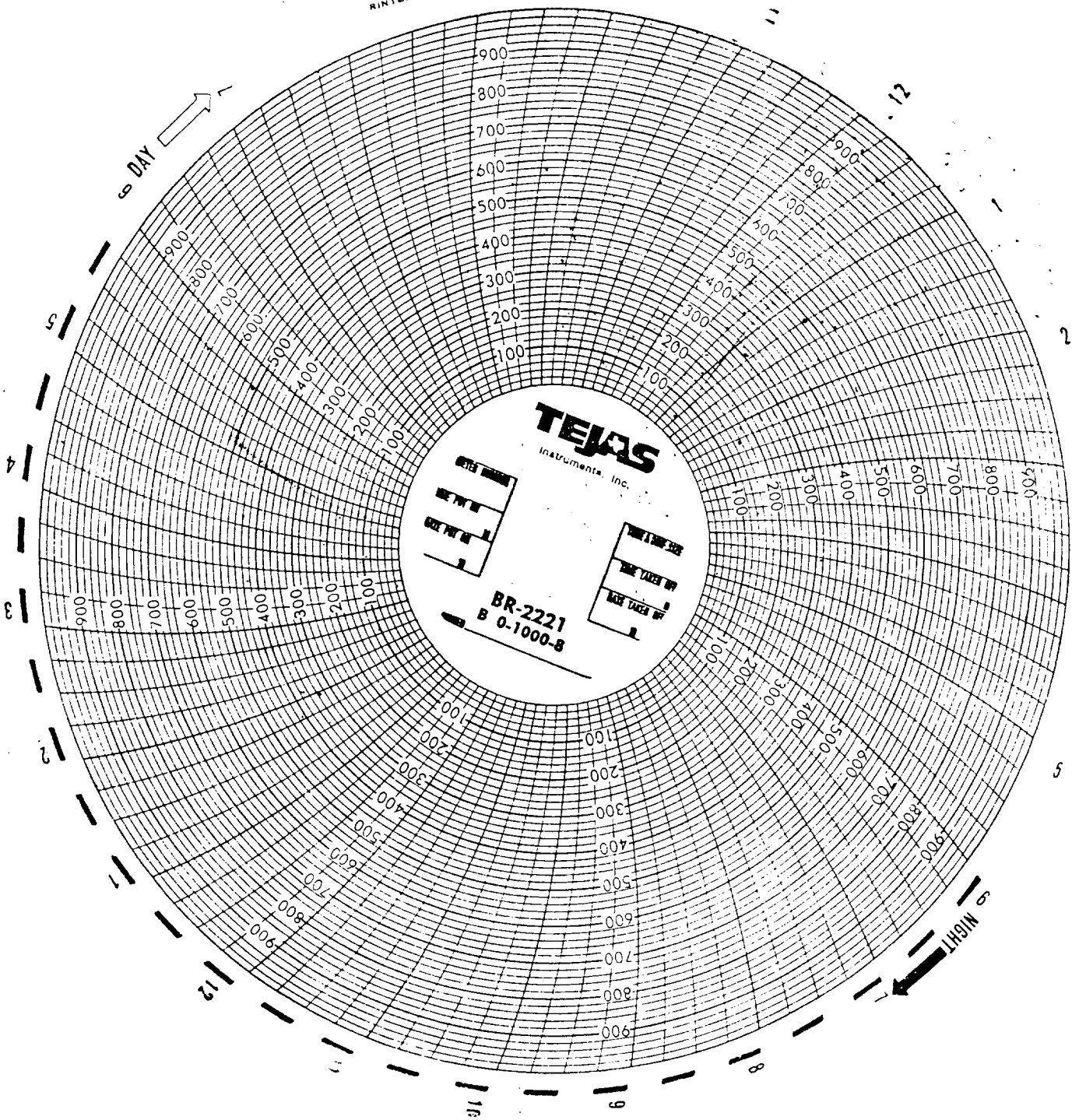
