On March 13, 1969, treated well as follows:

Set packer at 3383', pumped below and communicated above packer. Acidized perforations at 3338-3410 with 3,500 gals. 28% acid. Treated at 4.4 BPM at 2100 to 1700 psi. Straddled perforations at 3287-3312 and acidized with 1,500 gals. 28% acid. Treated at 1.7 to 4 BPM. Pressure broke from 3050 to 2300 psi.
