On March 18, 1969, cemented 4 1/2" O.D. 9.5# J-55 casing at 3603' with
200 sacks 50/50 pozmix with 6% gel plus 225 sacks neat incor cement. Pipe tested
OK with 1500 psi. for 30 minutes.
