- 11-11-89 This am prep set cast iron bridge plug and re-perf. Drld cement 2102' and fell thru. Circ'd hole clean. Press tested csg 350 psi for 30 mins. Ran 4 jts, tagged sand. Circ'd out 6' sand. Trpd. Laid down drill collars. Ran csg scraper. Trpd. Ran retrieving head. Circ'd out sand covering retrievable bridge plug. Trpd and laid down bridge plug. SDON.
