Pulled tubing and rods. Perforated 2076' - 2082' w/12 holes. Set retrievable bridge plug at 2150'. Frac down 5-1/2" casing using 30,000 gal. gel water and 30,000# 20/40 sand. Max. 2000#, Min. 1800#, Avg. Inj. rate 24 BPM. Pumped 13 BO and 76 BW/24 hrs. after frac load recovered from Queen Sand. Pulled retrievable plug 5-14-74 and started producing Queen, Grayburg and San Andres together.

Production Before: Pumped 12 BO. & 17 BW/D. Pfs. 2526' - 3877'.  
Production After: Pumped 25 BO & 93 BW/D. Pfs. 2076' - 3877'.
