1. Well spudded at 7:00 P.M. 1-31-72.

2. Ran 492' KB of 8-5/8" 20# casing as follows:

- Volume of cement equalled 132 cubic feet (100 sacks).
- Brand of cement was Southwestern Class C with 2% CaCl.
- Approximate temperature of cement slurry was 60°.
- Formation temperature was 86°.

3. After standing cemented for 9 hours compressive strength was 800#.

Pressure tested to 400#. Tested OK.

f. Drilled out cement after standing cemented 12 hours.

3. Ran 3675' KB of 4-1/2" 9.5# casing and cemented with 425 sacks cement.

4. We perforated as follows: 2480'-2490', 2542'-2548', 2586'-2594', 2663'-2669',
3284'-3292', 3398'-3403', 3418'-3423', 3553'-3561'.

5. We fraced and acidized as follows: 2480'-2490'-Frac 30,000# sand and 30,000 gallons gelled water.

2542'-2594' - Frac 30,000# sand and 30,000 gallons gelled water.

2663'-2669' - Acidized 3,000 gallons.

3284'-3292' - Frac 30,000# sand and 30,000 gallons gelled water.

3394'-3423' - Frac 30,000# sand and 30,000 gallons gelled water.

3553'-3561' - Frac 30,000# sand and 30,000 gallons gelled water.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
