26. Ran GR/CCL from 3228' to 1116'. Perforated Grayburg Formation from 2822' to 2826', 2860' to 2865', 2877' to 2881', 2893' to 2897', and 2960' to 2964' at 2 SFM.
Total holes = 26 with a .35 diameter.
27. WIH with retrievable bull plug and packer. Acidized all Grayburg perforations with 2100 gal. 15% NEFE acid. TOH.
28. WIH with 2-3/8" tension packer on 1½" plastic lined tubing. Circulated hole with fresh water and chemical; set packer @ 2733'. Tested casing to 500# in accordance with NMOCD rules and regulations.
29. Rig down pulling unit. Return well to injection.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
