15. Ran CBL from 1500' to surface and showed cement at 1338' to 1336', 1316' to 1272', and 474' to surface.
16. Perforated 4 squeeze holes at 1272'.
17. WIH with packer and cemented out perforations with 100 sx Class H with 2% CaCl and 2% sodium phosphate. TOH.
18. WIH with bit and drilled cement and cleaned out to 2700'. TOH.
19. Ran CBL from 1500' to 1100' and showed cement from 1338' to 1336' and 1314' to 1220'.
NOTE: Mike Stubblefield with NMOC approved salt section as being isolated.
20. WIH with bit and drilled out CIBP at 2700' and cleaned out to TD at 3163'. TOH.
21. WIH with 2-7/8" float shoe on 101 joints of 2-7/8" J-55, EUE, 8rd, tubing with 2-7/8" X 4-1/2" casing packer 16 jts. off bottom. Set float shoe at 3160' GL and packer at 2668' GL. Cemented with 100 sx lite cement and 50 sx Class H cement. Set packer. Did not circulate cement.
22. Ran temperature survey after 15 hours and showed good cement top at 975'. (Had 2 degree temperature change at 300'; possibly cement came up to 300' and fell back)
23. Pressured up on 4 1/2" braidenhead to 1000#. Bled off to 0# in 10 seconds. Pumped 200 gal. 15% NEFE down 4 1/2" braidenhead. Established rate and pressure at 2 BPM at 300#.
24. Ran tracer survey and established that all fluid pumped is going out hole at 473'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
