(1) The Etz-Randel State Cooperative Waterflood Project, previously approved and defined by Division Order No. R-7926, is hereby redesignated the Etz State Grayburg Unit Waterflood Project and expanded to include the N/2 NE/4 and the SE/4 NE/4 of Section 17, Township 17 South, Range 30 East, NMPM, Grayburg Jackson Seven Rivers-Queen-Grayburg-San Andres Pool, Eddy County, New Mexico.

(2) Devon Energy Corporation (Nevada) is hereby designated the operator of said Etz State Grayburg Unit Waterflood Project.

(3) The applicant is hereby authorized to convert two additional wells to injection as follows: Etz "J" State Well No. 22 located 990 feet from the South line and 2310 feet from the East line (Unit O) of said Section 16, and the Collier Federal Well No. 1 located 660 feet from the North and East lines (Unit A) of said Section 17.



- () 1. All pits have been filled and leveled.
- () 2. Rat hole and cellar have been filled and leveled.
- () 3. A steel marker 4" in diameter and approximately 4' above mean ground level has been set in concrete. It must show the quarter-quarter section or unit designation, section, township and range numbers which have been permanently stenciled or welded on the marker.
- () 4. The location has been leveled as nearly as possible to original top ground contour and has been cleared of all junk and equipment.
- () 5. The dead men and tie downs have been cut and removed.
- () 6. If a one well lease or last remaining well on lease, the battery and burn pit locations have been leveled and cleared of all junk & equipment.

The above are minimum requirements and no plugging bond will be cancelled until all locations for plugged and abandoned wells have been inspected and Form C-103 approved.
