1. Spud at 11:45 A. M. March 28, 1973.

2. Ran 460' KB of 8 5/8" 20# Casing as follows:

- Volume of cement equalled 132 cubic feet (100 sacks).
- Brand of cement was Southwestern Class C with 2% CACL.
- Approximate temperature of cement was 62°
- Formation temperature was 65°
- After standing cemented 9 hours compressive strength was 800#. Pressure tested to 400#. Tested OK.

3. Ran 3300' KB of 4 1/2" 9.5# casing and cemented with 320 sacks cement.

4. We perforated as follows: 2442'-2451' (16 holes); 2509-2512' (6 Holes); 2552'-2557' (10); 2625'-2630' (10 holes); 2780'-2788' (16 holes); 2986'-2988' (4 holes); 2998'-3000' (4 holes); 3022'-3024' (4 holes); 3070'-3078' (16 holes)

5. Fraced from 3070' to 3078' with 30,000# sand and 30,000 gallons water.
Acidized from 2986' to 3024' with 3,000 gallons.
Fraced from 2780' to 2788' with 30,000# sand and 30,000 gallons water.
Acidized from 2625' to 2630' with 2,000 gallons.
Fraced from 2509' to 2557' with 30,000# sand and 30,000 gallons water.
Fraced from 2443' to 2451' with 20,000# sand and 20,000 gallons water.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
