While coring at a depth of 3007', core barrel twisted off and we are unable to recover the stuck barrel. It is proposed to place a cement plug from top of fish at 2975' back to 2775'. Cement will be Class "C" with 2% CaCl + 10% sand. Hole will then be side-tracked in order to drill around core barrel.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
