13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. This Square Lake injection well failed a mechanical integrity test on 4/19/00. We have determined there is a leak in the 4 1/2" casing between 1430' and 1461'. We propose to Dig 40' x 40' working pit. Notify BLM and NMOCD 24 hours prior to start. Set BP and packer and do a "Micro Matrix" cement squeeze to seal any holes. Test well to 300# for NMOCD required 15 minutes. Return well to active injection status.
