Well is pumping about 100 barrels of water per day from perforations at 2843 to 2850'. It is proposed to set a drillable bridge plug at about 2860' and squeeze approximately 75 sacks of cement below a cementing retainer at about 2790'. Cement will be drilled out and well left to produce from 2874 to 3136'.
