Squeeze casing leak and acidize well as follows:
 COOH w/rods & pump, install BOP, COOH w/tbg. GIH w/csg. scraper, check TD & clean out as required. GIH w/packer type RBP & RTTS type pkr. on workstring tbg. Test 4½" csg. If leak is found in 4½" csg. dump 2 sx sand on RBP. Establish injection rate & pressure. Cmt. w/150 sx Class C cmt. w/2% CaCl₂. Flush tbg., release pkr. & COOH, WOC. GIH w/drilling equipment. If no leak found in 4½" csg. set RBP @ 2000', dump 2 sx sand on RBP & load hole w/2% KCL wtr. COOH w/ pkr. & tbg. Pump down 4½" x 8 5/8" csg. annulus & establish injection rate & pressure. (Hold 500 psi on 4½" csg. while pumping down annulus). Cement w/150 sx Class C cement w/2% CaCl₂. SION. Test 8 5/8" csg. GIH w/RBP tool & RTTS type pkr. on tbg. Acidize the GB/SA w/ 4250 gal. 15% NEFE HCL & 1220 gal. 7½% NEFE HCL acid.
 Return to production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
