Two Proposals

- (1) "Temporarily" transport (oil/gas/water) off-lease. From one segment to another (see attachment).
- (2) Lay a short (100') 2" polyethylene flowline connecting this well to an existing pipeline (BLM ROW NM 30514 dated 1977). Archaeological Survey Consultants (Roswell) has been scheduled for clearance.

The L,M&N portions of this lease already share the same tank battery (Center of Section 31). Although, only the Federal "N" is required to operate under a commingling Order (PLC-64) since it is in a different pool.

All these segments (L,M,N & K) share common ownership (both RI, ORRI & WI), common lease numbers (LC-028936d) and are all Federal.

The L,M & K share a common pool.

PURPOSE: To save the expense of building four tank batteries (only one is needed).
