On June 1, 1979, ran 2-3/8" O.D. plastic lined tubing with tension packer set at 2851'. Tretolite KW 37 packer fluid was circulated into the casing-tubing annulus for protection. We will either install a pressure gauge on casing, or leave open so that a high pressure leak can be detected. On June 4, started water injection below packer.

Instructions
