This SI WIW is unable to pass the State bradenhead test. We have been unable to repair the problem. We now propose to plug and abandon this well bore as follows: set dig small working pit, notify BLM and NMOCD. Set 4 1/2" CIBP @ 2900, dump 35' cement on top of plug. (perfs 2925'-3057'.) Our records show the TOC is 1504'. We would like to set a 4 1/2" CIBP @ approx 1520' and dump 35' cement on top. Propose to set a retainer in the 4 1/2" casing @ approx 525' and set a 50' cement plug. Our 8/24/83 records indicate a total of 120 sks cement was pumped into 8 5/8" x 4 1/2" casing annulus. We will pump enough cement to fill to surface. Nine(9)# mud will be used between all intervals. Install dry hole marker. Restore the location as directed by BLM.
