DEOC plans to plug and abandon this well as follows:

1. Set a CIBP @ 3265' w/35' of cmt on top.
2. Perforate @ 1520' and set retainer @ 1420' w/100' of cmt on outside and inside of 4 1/2" csg below retainer, and 35' of cmt on top of retainer.
3. Perforate at 860' and set a retainer @ 760' w/100' of cmt on the outside and inside of the 4 1/2" csg below the retainer, and w/35' cmt on top of the retainer.
4. Set a cement plug in the 4 1/2" csg from 0-50'.
5. Weld a marker on top of 4 1/2" csg.

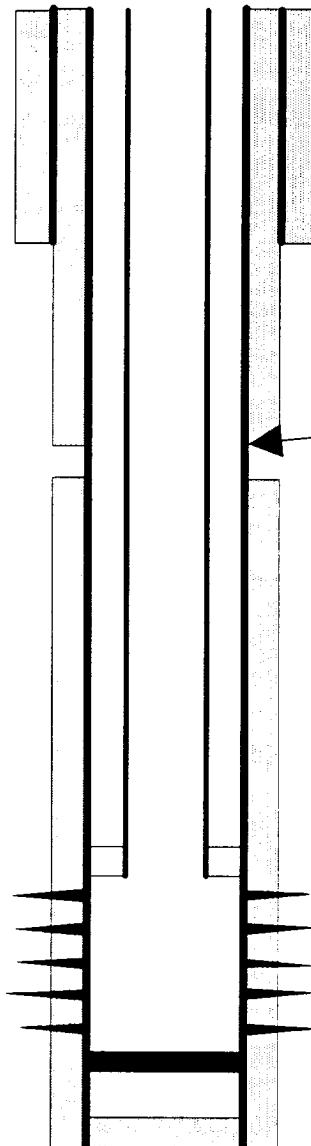

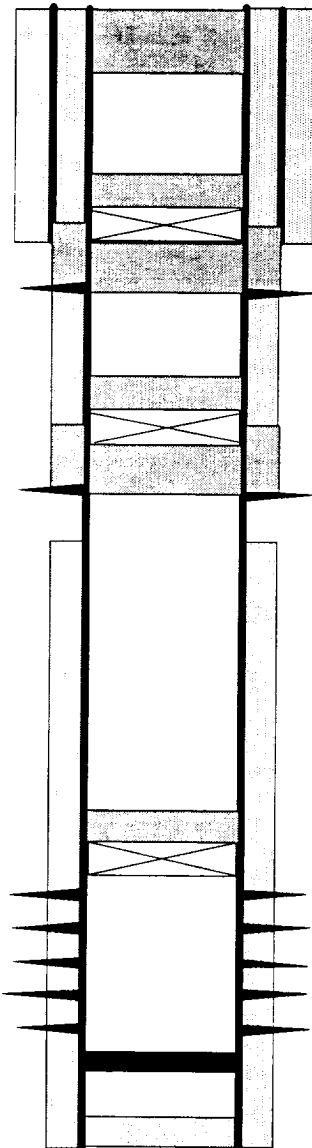
