- MIRU pulling unit. Install 11" 3000M BOP.
- Release packer @ 10,620', circ. POOH LD tbgs. and packer.
- RU electric line & run GR/JB to ±10,650'. POOH.
- PU CIBP, RIH & set at ±10,650'. POOH. RIH & dump bail 20' cmt. on top of CIBP.
- Load hole and test csg. to 500# for 30 minutes.
- Perforate from 8800' - 9100'.
- PU plastic coated Loc-Set pkr. & TIH with 2-7/8" 6.5# J-55 PC tbgs. to 8775'. Circ. pkr. fluid. Set pkr. & test csg. Space out.
- ND BOP & NU wellhead. Release rig.
- Pump 100 bbls. produced water into well and monitor pressure. If necessary, acidize with 3000 gals. 15% HCl as recommended.

Note: Estimated start date of proposed work will coincide with date of approval from State of New Mexico Oil Conservation Division and the BLM.
