Spud 7:00AM 8/13/82. Cemented 8 5/8" 23# J-55 casing at 505' with 150 sacks class "C" cement 2% calcium chloride 4% gel and 150 sacks class "C" 2% calcium chloride. Plug down 7:00 PM 8/14/82. Cement circulated. WOC 18 hours, tested casing with 500# for 30 minutes, test O.K.

Cemented 5 1/2" 15.5# J-55 casing at 3199 with 300 sacks 50/50 poxmix 2% gel with 6# salt and 1/4# floreal per sack and 200 sacks class "C" 4% gel. Plug down 2:00 AM 8/21/82.
