11-4-83 Spudded 12 $\frac{1}{4}$ " hole at 2:20 p.m. MST on 12-2-83. Depth 393 in redbed. ST- $\frac{1}{4}$ " at 393'. Set 9 jts of 8 5/8" 23# csg at 393'. Cemented w/100 sx Cl-c quick set and 5# gilsonite, $\frac{1}{4}$ # flocele, used 300 sx of Cl-C w/2% cacl. Cement did not circulate. Commission gave permission to use 10 yds of redi-mix fill to surface. Plugged down at 12:00 noon. WOC-12 $\frac{1}{2}$ hrs. Tested pipe to 600# for 30 minutes and also tested BOP - both held okay.
