

This well was converted to a water injection well as follows:

12/11/91-2/12/92 Cleaned out hole to 3475'KB. Ran plastic-coated 2-3/8"X5 1/2" tension pack on 89 jts. 2-3/8" EUE cement lined tubing and set at 2856'KB with 15,000# tension. Filled annulus with treated fresh water.

2/12/92 Commenced injection of fresh water into perforated intervals from 2896'-3463'.
