A 12 1/4" surface hole will be drilled to the Rustler Anhydrite. 8-5/8" casing will be run and cemented to surface. After testing casing, a 7-7/8" OD hole will be drilled through the Jackson zone @ ±3550'. Open hole logs will be run (if no water is flowing) and, if commercial, 5 1/2" casing will be run and cemented back to the base of the salt @ ±1250'. BOP equipment will be double ram, tested to 3000 psi before drilling 7-7/8" hole.
