9/3/96 - Drilled out CIBP @ 3900' & drilled out float collar & 20' cmt to new PBTD of 4057'. Perf'd w/1 SPF @ 3337', 3339', 3363', 4040' & 4042'; total 5 holes.

9/4/96 - Acidized perms 3337'-4042' w/6000 gals 15% HCl acid. Swabbed.

9/5/96 - Ran 5 1/2" nickel plated pkr @ set @ 3284' w/104 jts 2 3/8" PC tbgs. Tested to 300 psi for 30 min, OK.

10/15/96 - Began injecting.
