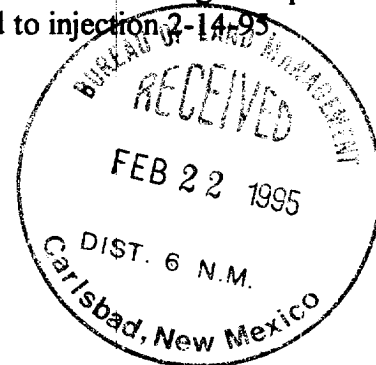
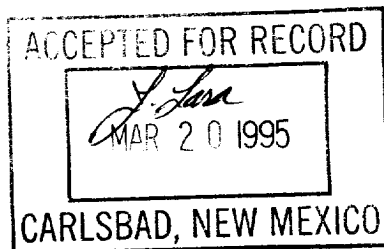
Drill out shoe joint & 4 3/4" open hole from 3960' to 4055'. Ran OH Neutron log. Perforate 3294', 3312, 20, 3867', 3931', 33, 35, & 41 w/1 JSPF using a 3 1/8" casing gun. Acidize interval 3294' to 40555' w/4000 gals. 15% NEFE acid. Ran 5 1/2" Guiberson G_6 nickel coated packer on new 2 3/8", 4.7#, J-55, plastic coated tubing. Set packer @ 3146'. Load annulus w/packer fluid & test @ 300 psi for 30 minutes. Well converted to injection 2-14-95
