3. Add perforations to Jackson interval 3836' - 3844' (OA).
4. RIH with Baker AD-1 packer on 2-3/8" tubing and set at 3100'.
5. Inject through perforations 3182' - 3844' (OA) and open hole 3868' - 3988'.
