THÍRTEEN POINT PROGRÁM

- 1. EXISTING ROADS: From Artesia go approximately 28.4 miles east on Federal Highway US-82. (This point is approximately 5.4 miles east of Loco Hills, New Mexico). From this starting point turn left (North) on dirt road and proceed in a northerly direction for 1.5 miles. Next turn left and proceed northwest for a distance of .4 miles. At this point the proposed new road begins. Turn left and proceed in a westerly direction (approximately) to drillsite.
- 2. PROPOSED NEW ROAD: The new road will run from the existing road west to the drillsite, a distance of approximately 300 feet.
- 3. LOCATION OF EXISTING WELLS: The nearest production to the proposed well is the Foster Eddy Federal #3 located northeast of the proposed drillsite. This well and all existing wells in the vicinity of the proposed drillsite are shown on Exhibits "B" and "C".
- 4. LOCATION OF EXISTING AND/OR PROPOSED FACILITIES:
 - A. This is a producing lease and central tank battery is located in the NW/4 SE/4 of Section 17-17S-31E.
 - B. If the well is productive, flowline will be laid along the proposed and existing roadbeds to the battery.
 - C. There are electric powerlines on the lease, the closest pole being located approximately 300 feet northeast of the well location. The proposed electric powerline would be approximately 250 feet in length and run from the above referenced pole to a pole in the Northeast corner of the well pad, which will have to be inserted.
- 5. WATER SUPPLY: It is not planned to drill a water supply well. Water for leasehold operations will be purchased from a commercial water hauler.
- 6. CONSTRUCTION MATERIALS: Material for construction of the proposed new road and well pad will be obtained from an existing approved caliche pit located on state land in the NEI/4 SWI/4 of Section 16-17S-31E.

7. WASTÉ DÍSPOSAL:

- A. Drill cuttings will be disposed of in the drilling pits.
- B. Drilling fluids will be allowed to evaporate in the drilling pits until the pits are dry.
- C. Water produced during tests will be disposed of in the pits.
- D. Oil produced during tests will be produced into temporary test tanks.
- E. Trash, waste paper, garbage, and junk will be buried in a trash pit and covered with a minimum of 24 inches of dirt. All waste material will be contained to prevent scattering by the wind. Location of the trash pit is shown on Exhibit "D".
- F. All trash and debris will be buried or removed from the wellsite within 45 days after finishing each drilling and/or completion operation.
- 8. ANCILLARY FACILITIES: None anticipated.
- 9. WELLSÎTE LAYOUT: Refer to Exhibit "D" for direction orientation and access.
 - A. The wellsite has been surveyed and an area has been staked and flagged.
 - B. The dimensions and relative location of the drill pad and pit with respect to the well bore are shown on Exhibit "D".
 - C. The location is nearly level but contains several sand dunes which will need to be leveled.
 - D. The well pad will be surfaced with caliche.

10. RESTÖRATION OF SURFACE:

A. After completion of drilling and/or completion operations, all equipment and other material not needed for operations will be removed. Pits will be filled and the location cleaned of all trash and junk to leave the wellsite in as aesthetically pleasing a condition as possible.

- B. Any unguarded pits containing fluids will be fenced until they are covered with soil.
- C. After abandonment, all equipment, trash and junk will be removed and the location cleaned. Any special rehabilitation and/or special revegetation requirements of the BLM will be complied with and accomplished as expeditiously as possible.

11. OTHER INFORMATION:

- A. Topography: The undisturbed wellsite is at an elevation of 3718.6 feet. The terrain of the area surrounding the location is relatively flat. Regional slope is to the southwest toward the Pecos River.
- B. Soil: Top soil at the wellsite is sand.
- C. Land Use & Type: The vicinity surrounding the drillsite is semiarid rangeland and its primary use is for production of oil and gas.
- D. Flora: Flora in the vicinity surrounding the drillsite is sparse. It consists primarily of javalina, saltbush, broomweed and mesquite.
- E. Faûna: No wildlife was observed, however fauna for this type of habitat normally consists of lizards, snakes, rabbits, rodents, coyotes, skunks, quail, dove, and other small birds.
- F. Ponds & Streams: None.
- G. Water Wells: The nearest known water well is over 4 miles to the southwest.
- H. Residences & Other Structures: There are no occupied dwellings within one (1) mile of the proposed drillsite.




