This notice is being sent to clear up any problems caused by the change in the casing program on this well. The application was originally submitted reflecting our intention to run two strings of pipe. After careful consideration of water flows that would be encountered, the decision was made to upgrade the casing design to include an additional string of casing. Due to a breakdown in communication and heavy work load, the sundry notice indicating this change was never sent to the BLM. This was not intentional. We always try to cooperate in following all Rules & Regulations set forth by the BLM & OCD. We will continually strive to accomplish this in the future.
