6/27/92 Spudded. Drilled 12 1/4" hole to 507'. Ran 11 jts. new 8 5/8" OD J-55 24# ERW ST&C casing (494'). Set at 505' KB. Cemented with 350 sks. Cl C, 2% CaCl. Circulated 30 sks. good cement to pit. WOC 12 hrs. Tested casing to 800 psig for 30 minutes. Okay.
6/28/92 to 7/5/92 Drilled 12 1/4" hole to 3589' KB TD 7/3/92. Found 1000 BWPD waterflow at approximately 2500'. Decreased to 100 BWPD by TD. Ran open hole logs. Ran 80 jts new 5 1/2" OD 17# R3 J-55 casing (3578'). Cemented at 3583'KB with 1000 gal. Superflush, 500 sks. Lite cmt, 630 sks. Cl. C with 6# salt/sk. Plug down and holding at 12:30 AM 7/5/92. Released rig.
7/23/92 Ran Gamma Ray/Casing collar/Cement Bond logs. Indicated good to excellent bonding. Top of cement 1180'. Tested casing to 4000 psi.
9/25/92 to 11/6/92 Perforated Jackson interval at 3346', 3347' 3410', 3411', 3449', 3450', 3462', 3464', 3466', 3468', 3470'. Acidized with 1000 gal. 7.5% HCL, fraced with 25,000 gal. gelled water and 51,250 # 20-40 sand. Perforated Lovington interval 3179'-3184'. Acidized with 750 gal. 15% HCL. Too tight to produce. Perforated Vacuum 3101'-3104'. Acidized with 700 gal. 15% HCL. Fraced with 13,200 gal gelled water and 20,300 # 20-40 sand.
11/12/92 Put on pump.
11/16/92 Tested 36 bbls. oil per day, 10 mcf gas per day, 264 bbls. water per day.
