On 1/1/95, we perf'd 4 squeeze holes @ 4000'. Spotted 250 gals 15% HCl acid on perfs. Squeezed perfs @ 4000' w/75 sxs Class "C" + 1% D-127 + 1% S-1.

On 1/4/95, we perf'd the Lovington 3566'-3571' and Mtd. Jackson 3700'-3890' (21 - .40" holes). The perfs were acidized w/2850 gals 15% HCl acid.

On 1/7/95, we perf'd the Grayburg 3222'-3440' (15 - .40" holes). The perfs were acidized w/2000 gals 15% HCl acid. We frac the zone w/42,600 gals x-linked gel + 99,000# 20/40 Brady-sand + 26,000# 20/40 resin coated sand.
