Rig up, pull rods and tbg out of hole. Run in hole w/SV Retainer and Squeeze old perms from 3012-3909 w/100 sx Class C Cement. Drill out Cement and pressure test casing to 500#. Perf casing from 4217-4521 w/35 shot. Acidize perms and put well back on production in the Loco Hill Paddock.
