We anticipate only using half of the pit, therefore only the half that we will utilize wil be lined with plastic. The other half of the pit will be lined w/plastic and used only if we encounter a waterflow during drlg operations and find that we will need additional room. This portion of the pit is a precautionary measure only. The portion of the pit that we are lining w/plastic should be more than adequate for normal drlg operations. If we do encounter a waterflow, we should have ample time to line the other half of the reserve pit w/plastic before the water encroaches.
